Entrant Participation Agreement

RULES AND REQUIREMENTS

A PURCHASE IS NOT NECESSARY TO ENTER THIS CONTEST

DATES OF CONTEST:

Contest opens on April 21, 2022 at 12:00AM Pacific Daylight Time (PDT) and closes on April 21, 2022 at 11:59PM PDT (the "Contest Period"). The submission period will begin on April 21, 2022 at 12:00AM PDT and Contestants must submit all entries no later than 11:59PM on April 21, 2022, PDT.

ELIGIBILITY:

Cat Pawsitive ("CP") is an initiative of Greater Good Charities ("GGC"), a 501(c)3 non-profit, public charity registered in the State of Washington with its principal offices located at One Union Square, 600 University Street, Suite 1000, Seattle, WA 98101. This Contest is intended for residents of the United States only, and by entering you agree that this Contest will be subject to and governed by the laws of the State of Washington, USA. This Contest is being conducted by GGC. No GGC employees and personal associates, families (including those with whom they reside), GGC directors, officers, representatives and agents of GGC may enter or participate as contestants.

All participants ("Entrants") submitting an entry ("Submission" or "Entry") to the Contest must meet the following criteria:

1. To be eligible to win, Entrants must be at least 18 years of age as of April 21, 2022.
2. All Submissions must be posted to one of the following Social Media Platforms: Facebook, Instagram, Twitter, or Tik Tok.
3. All Submissions must be the Entrant's own video footage or photography.
4. Entrants cannot include video clips or music created by others without the written permission of the underlying copyright owner.
5. All work must be submitted online in digital format.
6. Entrants may submit more than one entry.
7. Shelters nominated for grants must be based in the U.S. or Canada, and must be a 501c3 nonprofit, in country equivalent, or municipal shelter.

Use of any automated system to enter is prohibited and will automatically result in disqualification.

There is no limit on number of entries during the submission period.



GGC is not responsible for lost, late, mutilated, corrupted, or incomplete Submissions. GGC has no obligation to acknowledge receipt of or to return any Submissions received.

HOW TO ENTER:

Via one of the following Social Media Platforms: Facebook, Instagram, Twitter, or Tik Tok ("Platforms"):

1. All Submissions must be posted using a public Social Media account, with no privacy settings enabled to limit visibility of the posts.

Each Entrant and all others associated in the creation of the Submission(s) grants to GGC a perpetual, non-exclusive, royalty-free, worldwide, and irrevocable right to use, edit, alter, copy, reproduce, disclose, display, publish, prepare derivative works from, perform, distribute, exhibit, broadcast, or otherwise exploit the Entry(s), including photos, in whole or in part, in connection with the Contest and/or as, in GGC's sole discretion, any other GGC-related business use by means of any form, media or technology now known or hereafter developed, including, but not limited to, broadcast and cable television, radio, mobile transmission, and the

GGC reserves the right to take down a submitted Entry from the Fido Foster website, or to elect to not exhibit or promote any particular submitted Entry, or Entrant, even if the Entrant is a finalist or winner.

GGC reserves the right to terminate the Contest, amend Contest Rules or change Contest Rules at any time without prior notice. Any Entrant in the Contest shall have no legal recourse against GGC, its agents, assigns, advertising agency and consultants and their respective employees for any such changes, cancellation or termination.

These Contest Rules, in combination with any shown on the Contest website, constitute the entire agreement between the Entrant and GGC regarding any and all participation and supersede any other written or oral communications you may have with anyone, including any phone calls to our staff. This Entrant Participation Agreement shall be governed by the laws of the State of Washington, USA.

SELECTION AND JUDGING:

From the close of the submission period to April 22, 2022, Greater Good Charities and its representatives shall select three (3) winning entries (the "Winners"). Entries shall be judged on entry creativity. Winners will be announced on April 22, 2022.

PRIZES - TYPES:

GRAND PRIZES

There will be one (1) Entry selected for a grand prize.

Grand Prize

- One (1) \$5,000 cash grant to a shelter of the winner's choice and approved by GGC

RUNNERS UP PRIZES

There will be two (2) Entries selected for a runner up prize.

First Runner Up

- One (1) \$3,000 cash grant to a shelter of the winner's choice and approved by GGC

Second Runner Up

- One (1) \$2,000 cash grant to a shelter of the winner's choice and approved by GGC

PRIZE REDEMPTION:

By Social Platforms:



All eligible Winners will be contacted by GGC at the end of the contest utilizing the Social Media Platform used by the Entrant. The Prize may be forfeited by an eligible Winner if that eligible Winner cannot be contacted within seventy-two (72) hours after the end of the Contest. Odds of winning prizes do not depend on the total number of eligible entries received during the Contest Period. None of the prizes awarded may be substituted and are not transferable.

GENERAL CONDITIONS:

If the identity of an on-line Entrant is disputed, the authorized account holder of the e-mail address submitted at the time of entry will be deemed to be the Entrant. The individual assigned to the e-mail address for the domain associated with the submitted e-mail address is considered the authorized account holder.
